Citizenship Qualifications

Applicants should act in accordance with the subsequent criteria so as to be granted Turkish citizenship:

- Applicant must have opened a bank account and make necessary investments.
- Applicant must be holding a valid residence permit. However, investors don't get to maintain residence in Turkey and that they may reside in their home country as long as they want.
- Applicant must submit the required documents including CNIC MRC FRC, Pictures and an official statement from the concerned ministry.
